Due to the present COVID-19 Pandemic situation, in connection with the Annual DDE Examinations for the Academic year 2019-20, all the students of Prak-Sastri, Sastri, BA & Acharya Programmes are hereby informed to follow the below mentioned instructions as per the Guidelines of the UGC and the resolutions of the NSU vide reference (i) and (ii) cited above, and do the necessary.

(1) Payment of exam fees and submission of Examination application forms:

- (i) The last date of submission of examination application form along with the fees is extended upto 30th June, 2020 for Sastri, BA & Acharya Courses. The application form has to be reached to "The Director, Directorate of Distance Education, National Sanskrit University, (Erstwhile Rashtriya Sanskrit Vidyapeetha), Tirupati - 517 507 (A.P.)"
- (ii) Due to the COVID-19 pandemic situation, if the student finds difficult to get the demand draft and also to send the examination form, the student is allowed to pay the fees directly into the NSU Examination Bank account bearing a/c No. 146610100001963 of Andhra Bank (IFSC code ANDB0001466 of RSV branch) duly mentioning the details of payment (i.e. UTR number or transaction ID at the exam form) and scan the fully filled exam application form along with all the enclosures and send in PDF format via email to "directorordersvp@gmail.com".

(2) General Information :

- # 50% of the marks will be awarded on the basis of the Assignments being submitted by the students and 50% of the marks will be awarded on the basis of Online examinations (only for 2020 DDE annual examinations).

- # Students in the Assignments have to write two (02) Answers of 25 marks each (minimum 5 to 10 pages) from the questions framed **[except for Prak-Sastri 1st & 2nd year students where the assignments can be written on any topic of their CHOICE]** which will be made available on the University website by 26.05.2020 and have to submit the Assignments via Post or through PDF file (seperately for each course/ paper) via post or send through email to “**directorddersvp@gmail.com**” as per the available resources to the students.
