WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Rashtriya Sanskrit Vidyapetha, Tirupati, Andhra Pradesh has submitted an application to the Southern Regional Committee of NCTE for grant of permission to Rashtriya Sanskrit Vidyapetha, Tirupati, Chittor-517502. Andhra Pradesh for M.Ed course of one year duration with an additional intake of 15 (Fifteen) Students.

- AND WHEREAS on scrutiny of the application submitted by the institution, 2. the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the said teacher education programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratories etc for running the programme and has appointed duly qualified teaching staff as per NCTE norms.
- Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the NCTE Act, 1993, the Southern Regional Committee hereby grants permission to Rashtriya Sanskrit Vidyapetha, Tirupati, Chittor-517502. Andhra Pradesh for conducting M.Ed course of one year duration with an additional intake of 15(Fifteen) (10+15=25) thereby making total intake of 25 (Twenty five only) students under clause 7(12) of Regulations dated.13.01.2006. This order of recognition shall be prospective and take effect from the date of issue of this order, subject to fulfillment of the following:
 - i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.
 - iv) The institution will ensure that Principal and Six faculty members duly approved by the affiliating University are in position for an intake of 25 students before commencement of the course and a report to this effect shall be sent to the Southern Regional Committee immediately.

Preamble:

The Rastriya Sanskrit Vidyapeetha, Tirupathi, Andhra Pradesh has been granted recognition with an intake of 100 students for B.Ed course.

The Government of India in Central Educational institution (Reservation in Admission) Act, 2007, has made separate quota for OBCs. The Central Government has decided to enhance the intake of Government institutions for providing reservations under the said Act to the OBCs.

The Rastriya Sanskrit Vidyapeetha, Tirupathi, Andhra Pradesh has made application on 17.09.2008 requesting for increase of intake of 27 students in view of the above Act.

The NCTE. New Delhi in its letter dated 20.06.2008 has informed to consider on priority the applications received under the above category for increase in intake.

The application submitted by the Rashtriya Sanskrit Vidyapeetha for increase in the intake from 100 to 127 was placed before SRC in its 165th meeting held on 27th and 28th September, 2008. The SRC considered the matter and decided to enhance the intake of the institution from 100 to 127 subject to providing infrastructural and instructional facilities as per NCTE Norms and Standards.

Hence the order.

WHEREAS in terms of Section 15(1) of the NCTE Act, 1993 Rashtriya Sanskrit Vidyapeetha, Tirupati-517064, Chittoor District, Andhra Pradesh has submitted an application to the Southern Regional Committee of NCTE for grant of permission for conducting B.Ed course with an additional intake of 27 students on 17.09.2008 as per the provisions of the Reservation in admission Act, 2007.

Now, therefore, in exercise of the powers vested under Section 15(3)(a) of the 2. NCTE Act, 1993, the Southern Regional Committee hereby grants permission to Rashtriya Sanskrit Vidyapeetha, Tirupati-517064, Chittoor District, Andhra Pradesh for conducting B.Ed course of One year duration with an annual intake of 127 (One hundred and twenty seven) students which includes the existing intake of 100(Hundred) students and an additional intake of 27 (Twenty seven) students from the academic session 2008-09 under clause 7(11) of NCTE(Recognition Norms & Procedure) Regulations, 2007 subject of fulfillment of the following conditions:
