Sub: R.S.Vidyapeetha Hostels – Maintenance of Messes – Supply of Provisions -Invitation for Tenders – Regarding.

The R.S. Vidyapeetha Hostels are running Three Messes Viz., Srinivasa, Balaji and Padmavathi Mess and one Transit Hostel Mess (Guest House). Sealed Tenders are invited from the interested bidders in the field for Supply of Provisions for a period of six months w.e.f. 1st July, 2019 to 31st December, 2019. The list of provisions is enclosed. The tenders should be submitted between 10.00 am to 03.00 pm on or before 27th June, 2019 on all working days. RSVP observes five day week (Monday to Friday). The sealed Tenders will be opened at 04.00 pm on 28th June, 2019 in the presence of the bidders whose tenders are accepted for processing.

Terms & Conditions:-

- 1. The duration of the Rate Contract is 6 months from 1st July, 2019 to 31st December, 2019;
- 2. Tender document can be downloaded from our website and payment of Rs.1120/-by means of a DD drawn in favour of The Registrar, RSVP, Tirupati. TDF should be enclosed to the Annexure.
- 3. Earnest Money Deposit of Rs.75,000/- shall be paid by means of a DD drawn in favour of Registrar, RSVP payable at Tirupati. This is a non-interest bearing deposit which will be returned to all the parties on or before 31st July,2019. Tenders received without EMD will be rejected.
- 4. The bidder shall submit the Tender in a sealed cover super scribing as "Tender for Provisions";
- 5. The Tender should be dropped in the Tender Box available in the Office of the Registrar personally between 10.00 am to 03.00 pm on or before 27th June, 2019 on all working days. RSVP observes five day week (Monday to Friday);
- 6. Incomplete Tenders, Unsigned Tenders, Conditional Tenders and Late Tenders will be rejected straight away;
- 7. The supplier shall quote the reasonable and competitive prices;
- 8. Supplier shall quote for all the items in the list, otherwise the Tender will be disqualified;
- 9. Wherever specific brands are mentioned for some items in the list, the bidder shall quote for all the brands, otherwise the Tender is considered as incomplete and rejected out rightly;

- 10. The items listed from Sl.No 01 to 30 are considered as "Main Items" with high consumption and the bidder who has quoted overall L1 price for these "Main Items" only will be awarded with the Rate Contract;
- 11. Tenders containing abnormally high/abnormally low & unrealistic prices to any of the items in the list shall be rejected summarily;
- 12. The Tenders shall have proper seal of the company and signature of the authorised person;
- 13. The bidder who is awarded with the Contract should supply the Provisions at the hostels & Guest House at his own expenses and risk;
- 14. Net weight only will be considered for payment;
- 15. Wastage and damage of the Provisions should be replaced by the bidder;
- 16. Warden has full rights to extend/cancel the Contract partially/ fully with due justification;
- 17. Photo copies of Registration of the Firm, Pan Card & GSTIN in the name of the shop, are to be enclosed to the Tender, without which the Tender shall not be considered;
- 18. The items supplied should be pure, good quality and ready to use;
- 19. The Contractor should have a registered firm in Tirupati;
- 20. The Contract should not be sub-leased to anyone in any manner. Any complaints in this regard results in cancellation of the Contract;
- 21. Losses incurred by the Hostel due to non-supply, part-supply, late supply and supply of low quality items will be deducted from their monthly bills;
- 22. The Contractor should send the bill along with the material clearly indicating the name of each item with weight/quantity of units, as the case may be;
- 23. The Contractor should submit a consolidated bill on the last day of every month. No part-payment or advance payment will be made under any circumstances. The payment will be made on or before 15th of the following month by NEFT/Cheque;
- 24. Income-tax @2% & IT on GST at applicable rate will be deducted from the payments if the bidder is a company/firm. If the bidder is an individual sole proprietor, income-tax @1% & IT on GST will be deducted and TDS Certificate will be issued by RSVP;
- 25. The bidders are advised to be conversant with the terms & conditions as stated above before accepting the Contract;
- 26. Considering this Contract as "Contract for essential items", RSVP reserves the right to enter into Parallel Contracts for the same item at same rate. For this purpose, RSVP may issue Counter Offers to L2, L3 etc to supply the items at L1 rates;
- **27.** <u>Fall Clause:-</u> In case, if the Contractor supplies the items as specified in this Contract at a lowest price to any other party, during the period of Contract, that lowest price will be applicable to this Contract also;
- **28.** <u>Risk Purchase:-</u> If the Contractor fails to supply the requisite quantity/quality of the material, RSVP is at liberty to purchase such items from the local market to meet their requirements and claim the difference in price on higher side from the Contractor / deduct from the bills on hand;

- 29. There should not be any correction/overwriting in the Tender. Corrections, if any, should be encircled in red ink and initialled by the bidder and corrections without initials, results in rejection of bid;
- 30. RSVP hostels provide Breakfast, lunch and dinner to 1300-1400 students daily. Whenever there is a vacation to the students on account of Dasara, Sankranthi and summer holidays, the requirement will be reduced drastically/ NIL. However, the Contractor will be informed in advance about the vacation;
- 31. The prices mentioned in the Contract are firm and fixed and no request for increase of price will be entertained during the period of the Contract;
- 32. The prices quoted by the bidder shall be inclusive of all taxes and duties;
- 33. "Bidders shall fill the price column alone" in the enclosed Annexure and affix the shop seal with signature and date and put in a cover and sealed. Bids without signature & seal, will be rejected out rightly.

No separate Tender is required;

- 34. In case of any dispute between RSVP and the Contractor, the decision of the Warden, RSVP is final and binding on both the parties;
- 35. RSVP reserves the right to delete any items from the list while finalising the Rate Contract;
